Previous Roof Repairs – raccoons tore up shingles in 2018. Roof was completely replaced and attic vents were also added in.

Diseased Trees – 2 Chinese Tallow trees died in the severe winter storm of 2021. All other trees were inspected and pruned in January, 2022 and are considered to be in healthy condition.

Settling – concrete skirt around the house did show signs of cracking but these were repaired through the years.

Water Damage Not Due to a Flood Event – wind driven rain entered through a new window in the spare bedroom requiring the window sill plaster to be replaced and fixed. Insufficient grouting around the new window caused the problem and was fixed.

Wood Rot - rotted wood in the eaves area was replaced in 2018 when new roof was added on.

*A single blockable main drain may cause a suction entrapment hazard for an individual.
